Notice of Motion of SkyGreece Airlines S.A. returnable on September 8, 2015

On Saturday, September 5, 2015, at 5:50 pm (Atlantic Time), counsels for SkyGreece Airlines S.A. ("SkyGreece") sent me by email a Notice of Motion returnable on September 8, 2015 and the affidavit of Mr. Brooks Pickering, sworn on September 4, 2015.

I am a resident of Halifax, Nova Scotia. SkyGreece did not provide me with a 7-day notice as required by *Rule 37.07(6)*, and I will be unable to attend court in person on September 8, 2015.

I intend to oppose the motion, which raises important and novel questions of public policy and law, including whether the motion is statute-barred and/or preempted by ss. 41, 54, 25, and 30-31 of the *Canada Transportation Act*, S.C. 1996, c. 10. I intend to file an affidavit, I will likely choose to cross-examine Mr. Pickering, and I intend to file a factum.

I am writing to ask that the Honourable Court:

- adjourn the hearing of the motion; and
- approve the attached proposed Case Timetable.

I would also like to advise the Court that I will be unavailable during normal business hours on September 14-25, 2015 due to two hearings before the Federal Court of Appeal in Halifax, and my duties as a member of a provincial adjudicative board (Assistance Appeal Board).
