Re: Dr. Gábor Lukács v. Canadian Transportation Agency and British Airways Plc Federal Court of Appeal File No.: A-366-14 Request for directions

I am writing to seek directions from the Honourable Court with respect to the present appeal, which is set down to be heard on March 19, 2015.

## I. New authorities affecting the standard of review of procedural fairness issues

One of the two grounds raised by the present appeal is denial of procedural fairness. Since the filing of the Memorandum of Fact and Law of the Appellant, this Honourable Court released its decision in *Air Canada v. Greenglass*, 2014 FCA 288, where it was held that:

As indicated above, I intend to restrict my analysis to the procedural fairness issues raised by Air Canada. In this respect, there can be no doubt that these issues must be assessed against a standard of correctness (See *Mission Institution v. Khela*, 2014 SCC 24, [2014] 1 S.C.R. 502 at paragraphs 79 and 83).

In light of this new development, I am seeking the permission of this Honourable Court to depart from the position I took at paragraph 27 of the Memorandum of Fact and Law of the Appellant, and to argue at the hearing of the appeal that the issue of procedural fairness be reviewed on a standard of correctness.

## II. Treaty cited by British Airways is not in force

British Airways refers to an "air services agreement" between Canada and the European Union (the "Agreement") at paragraph 43 of its Memorandum of Fact and Law.

According to the October 28, 2014 email of Ms. Heather Bystryk, a Senior Trade Policy Analyst at the Office of the Chief Air Negotiator at FATDC (Foreign Affairs, Trade and Development Canada):

The agreement is not yet in force because some European Union Member States have not yet completed their domestic procedures to be bound by the treaty.

:

The Government of Canada can provide you with the official authentic text of the treaty only after the treaty enters into force. Once the agreement has entered into force, you will be able to find the text on the Canada Treaty Information website (http://www.treaty-accord.gc.ca/).

I have made a total of six (6) attempts to communicate with Ms. McCall, counsel for British Airways, in order to obtain an authentic copy of the Agreement and/or to confirm that she would advise this Honourable Court that the Agreement is currently not in force and was not in force at all material times. Unfortunately, my attempts have been unsuccessful.

Since the Agreement was not included in the Appeal Book nor in British Airways' book of authorities, it is unclear how British Airways intends to rely on the Agreement; however, I remain concerned about the possibility that British Airways may nevertheless attempt to rely on the Agreement at the hearing of the appeal, even though it is not in force and no authentic copy is available.

I am therefore asking for the guidance of this Honourable Court as to how the issue of the Agreement should be handled.

The agreement is not yet in force because some European Union Member
States have not yet completed their domestic procedures to be bound by the
treaty.
For Canada, the agreement was tabled in the House of Commons on 8 May 2013
in accordance with the Policy on Tabling of Treaties in Parliament. The
required 21 sitting day waiting period expired on 14 June 2013. An Order
in Council, authorizing Canada to ratify the agreement was granted by the
Governor General on 10 April 2014 (PC Number 2014-0426). Canada
subsequently notified the European Union, through diplomatic note, of the
completion of Canada's internal procedures on 7 May 2014.
The Government of Canada can provide you with the official authentic text
of the treaty only after the treaty enters into force. Once the agreement
has entered into force, you will be able to find the text on the Canada
Treaty Information website (http://www.treaty-accord.gc.ca/).
